- The Lewes City Code prohibits “any unreasonable, loud, disturbing and unnecessary noise,” including, in most situations, outdoor amplified music or other noise. See Chapter 132 of the Lewes City Code.
- Amplification Request Form must be submitted to the Lewes City Manager’s office for approval. You are strongly advised to obtain this approval before entering into contracts or agreements with bands, DJs, etc.
- Requests to have amplification must be submitted to the City **60 DAYS before** the event and/or wedding.
- Business and its employees, contractors and participants agree to indemnify and hold harmless the City of Lewes, Lewes Parks & Recreation Commission, and its employees and volunteers from any liabilities of any nature whatsoever, and all losses arising from or related to, directly or indirectly, any recreation event, any negligent act or omission or misconduct of the business, organization, its employees, members or agents.
